I have read and fully understand the above provisions and agree to comply by said provisions.

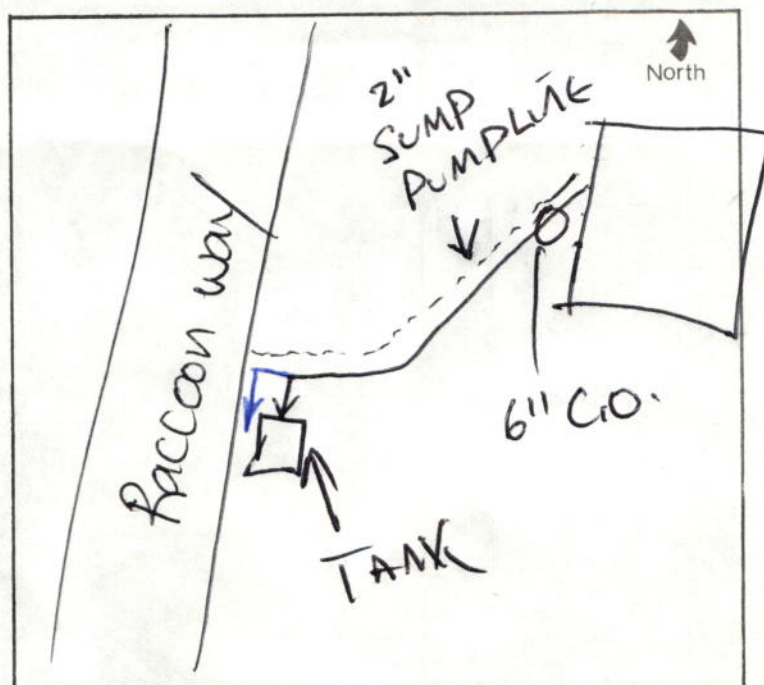
