This letter is intended to clarify our position as concerns wastewater services.

As of our recent billing the attached copy of our bill shows an amount due of 109.46. After 3/13/86, the amount due will be \$111.53. This wastewater utility bill will be filed against the delinquent taxes on the referenced property.

As discussed the certified letter was received by Cherie Neeley on January 24, 1986. This letter allows 90 days within which the tap-on fee will be \$150.00. After that time, the fee will be \$500.00. If, as you mentioned, a prospective buyer wishes to pay the \$150.00 tap fee (plus a \$25.00 inspection fee), then later decides not to purchase the property we can refund the \$175.00.
