Your delinquent sewer connection fees have become a matter of serious concern.

You are hereby notified that a pay agreement for the delinquent portion of your connection fee and sewer bill is to be entered into within ten (10) days of receiving this notice or payment of the entire balance is to be made within sixty (60) days of receiving this notice. If payment of the entire balance is not made within sixty (60) days of receiving this notice and a pay agreement has not been entered into, Fall Creek Regional Waste District will disconnect sewer service from 6132 S Fox Court, Pendleton, IN 46064 and the matter will be referred to the Madison County Health Department for additional action.
